



# Paw Paw Public Schools iPad Use & Insurance Agreement



1. I read, understand, and agree to abide to the terms of the Paw Paw Public Schools iPad Acceptable Use Policy.
2. I give permission to Paw Paw Public Schools (the "School District") to open an iTunes user account with my child.
3. I consent to the School District assigning an iPad owned by the School District to my child (the iPad assigned to my child, the "Assigned iPad"). I understand that all users of the Assigned iPad have no expectation of privacy in the Assigned iPad or its contents. I further understand that School District staff may monitor and inspect the Assigned iPad and all contents of the Assigned iPad, including emails and files, at any time without notice. Additionally, I understand the Assigned iPad shall remain the property of the School District at all times, and I agree to return the Assigned iPad to the School District upon the School District's demand. I consent to my child's use of the Assigned iPad and the iTunes account, and I assume the risks associated with my child's use of the Assigned iPad and iTunes account.
4. I discussed the student Paw Paw Public Schools Educational Network Acceptable Use Agreement with my child and I agree to ensure my child's compliance with the student Paw Paw Public Schools Educational Network Acceptable Use Agreement outside of school.
5. I discussed the Paw Paw Public Schools iPad Acceptable Use Policy with my child and I agree to ensure my child's compliance with the Paw Paw Public Schools iPad Acceptable Use Policy outside of school.
6. I agree to be liable the School District for all damage to the Assigned iPad. I understand that the average cost to repair a broken iPad screen is \$150.00. I further understand that all repairs to the Assigned iPad must be authorized by the School District in writing, and repairs must be performed by a repair facility of the School District's choice. In the event the Assigned iPad is lost, I agree to be liable to the School District for the full value of the Assigned iPad: \$479.00. Furthermore, I agree to pay for all costs arising from my child's use of the Assigned iPad and iTunes account. The School District, at its sole discretion, may permit a meeting for purposes of assessing liability. In light of my potential liability, I choose to enroll in one of the following plans:

**Plan 1: Family Pay Plan**

In the event of damage to the Assigned iPad or loss of the Assigned iPad, I agree to pay the School District the full repair or replacement cost of the Assigned iPad.

**Plan 2: iPad Repair Fund Plan.**

I agree to pay the School District \$25.00 (\$50.00 family cap) annually, which is due at the time my child receives the Assigned iPad. This payment will absolve me of any liability arising from damage to the Assigned iPad or from loss of the Assigned iPad, except intentional damage and misuse. Notwithstanding the preceding sentence, after the first repair or replacement of the Assigned iPad, I agree to pay \$25 after each repair and replacement. I understand that any payments made to the School District for the iPad Repair Fund Plan are non-refundable. Payments received under the iPad Repair Fund Plan will be placed into an iPad Repair Fund, which will be used to repair and replace iPads assigned by the School District to students of the School District.

7. I hereby agree to release, indemnify, and hold harmless, in both my personal capacity and as a guardian of my child, the School District, the School District's agents, and the School District's employees from any claims arising from my child's non-compliance with the Paw Paw Public Schools iPad Acceptable Use Policy and the Paw Paw Public Schools Educational Network Acceptable Use Agreement. The claims referenced in the preceding sentence include, but are not limited to, claims arising from materials my child downloads and relationships my child establishes with people online, regardless of whether these are accomplished through school accounts or personal accounts.
